

Raman Police Station Announcement Anti-Bribery and No Gift Policy

According to the Constitutional Assembly Act on Prevention and Suppression of Corruption B.E. ഉപ്പോ, Section ചെട്ട, paragraph one. It is stipulated that no public official shall receive any property or other benefit which may be calculated as income from any person other than assets or legitimate interests. rules or regulations issued by virtue of the provisions of law except for the receipt of assets or other benefits by virtue of the rules and amounts prescribed by the Board of Directors. The NCC stipulates and the Code of Ethics for Police Officials B.E. しょしん (しゅしゅの) Honesty and Integrity Comply with legal obligations Transparency of the Royal Thai Police. Refrain from engaging in behavior that implies unlawful exploitation. Responsible for human rights obligations Be ready for audits and accountability. Have a good conscience and take into account society and Article ७ (๔) considers the common good more than the personal interest. Have a public spirit, cooperate, cooperate and make sacrifices for the common good and create happiness for society in conjunction with the National Reform Plan on Prevention and Suppression of Corruption and Misconduct (Revised Version) Define key reform activities Activity & Develop the Thai bureaucracy to be transparent and without benefits Goal Article a.a All government agencies shall declare as agencies that all government officials do not accept gifts and gifts of any kind from the performance of their duties. (No Gift Policy)

Therefore, in order to prevent conflicts between personal and public interests. (Conflict of Interest) Bribery, gifts, gifts or any other benefits that affect the performance of duties. (Anti-Bribery Policy) and not accepting gifts, gifts or other benefits (No Gift Policy) from performing duties, with details as follows:

Article This Notice

"Supervisor" means a person who has the authority and duty to command, supervise, monitor and inspect police officers under them (can be adjusted according to the wording of the police).

"Bribe" means property or any other benefit given to a person to induce him to act or not to act in office. Whether it is rightful or unlawful with duty.

"Performance of duties" means acts or performance of duties of public officials. In the appointed position or be assigned to perform any duty or to act on behalf of the government. in any one of the duties, both generally and only as police officer as defined by law or it is done in accordance with the authority and duties specified by law to have the authority and duties of the police.

"Gifts, gifts or any other benefits affecting the performance of duties" means money, property, services or any other benefits that are valued and include tips received by government officials in addition to salary. Income, government benefits in normal cases and affect decisions, approvals. or any other act in the performance of duties in a manner that facilitates dishonesty to the gift giver either in the past or at the time of receipt or in the future.

Offences of giving and receiving bribes under the Criminal Code

Section new Whoever demands, receives, or agrees to receive property or any other benefit for himself or others in return in order to motivate or motivate officials. Member of the State Legislature Members of provincial councils or municipal councils by fraud or illegality or by its influence to act or not to act in the performance of duties which are yours or injurious to any person. Imprisonment not exceeding & years or a fine not exceeding no,000 baht or both.

Section acc Whoever gives, asks or accepts to give property or any other benefit to an officer Member of the State Legislature Member of Provincial Assembly or Member of Municipal Council. To motivate them to act. Imprisonment not exceeding & years or a fine not exceeding ao,ooo baht or both.

Section ack Whoever is an officer Member of the State Legislature Member of Provincial Assembly or Member of Municipal Council. Unlawfully demanding, accepting, or agreeing to receive property or other benefits for oneself or others to act or not to act in any

position whether it is lawful or unlawful to perform duties. Imprisonment ranging from &bo years or life imprisonment and a fine ranging from b,000-c0,000 baht or death.

Section aco Whoever is an officer Act or not act in office for the sake of any other property or benefit which he has demanded or agreed to receive before he was appointed as an officer in that position. Imprisonment ranging from &-bo years or life imprisonment and a fine ranging from b,000-c0,000 baht

Article & Police officers at all levels shall behave. as follows

o. Do not ask, lead, give or not accept bribes, gifts, gifts or any other benefits from performing duties. **b**. Do not consent or knowingly allow family members to give or accept bribes, gifts, gifts or any other benefits to those involved in the performance of duties.

m. The performance of duties must adhere to fair law enforcement, taking advantage of the interests and image of the police. Must not commit any act that is a conflict between personal interests and the common good. such as receiving gifts or other benefits that affect the performance of duties, utilization of government resources for personal benefit, Disclosure of inside information, obstruction of official hours for part-time work, etc.

«. Reduce the giving or receiving of assets or other benefits by virtue according to the rules and amounts specified by the Office of the NACC. Instead of giving items, you can express yourself by signing greeting cards, booklets, condolence cards, or using social media.

&. Refuse Not tolerated. Not indifferent. Against the behavior of accepting bribes, gifts or any other benefits from the performance of duties. If any violations are found, report them to the Superintendent of Kabang Police Station. Know ASAP

Article $\mathfrak m$ The supervisor shall have the authority and duty to supervise, monitor and inspect the police officers under the subordinate to comply with this announcement. In case of any violation of this notice, report it to the Superintendent of Kabang Police Station. Know ASAP

Article & Any person found to be in violation of this Notice. Complaints can be made directly through the Superintendent of Raman Police Station. or call ഠ๘๑ ๘๙๘ ៧២๙๔ where the complainant/whistleblower information will be kept strictly confidential.

Article & In case of receiving complaints/clues Personnel affiliated with such offences at the police station will investigate the facts. And if found guilty, the offender will be punished according to the law. Strictly related rules and regulations. and deliver the matter according to the hierarchy of command.
